Oasis High School began as the Oasis Independent Study Program of the Fallbrook Union High School District in January 1994. It became Oasis High School, the third high school in the District in 1995, for the purpose of providing a second alternative learning setting and modality complementing the traditional Fallbrook High School and to serve the students and parents/guardians of FUHSD and neighboring districts who voluntarily opt for the learning modality of independent study. The three high schools in the Fallbrook Union High School Districts serve grades 9-12 and have a total enrollment of approximately 3,000 students.

Oasis High School is accredited by the Western Association of Schools and Colleges (WASC) as an alternative high school providing the continuously voluntary option of independent study to qualified students from both FUHSD and adjoining districts. Each student has the continuously available option of returning to seat-time instruction in a regular classroom. The Oasis High School staff is proud of the exceptional academic progress, personal growth, and social success its graduates have experienced. Teachers, parents/guardians, and students share and support a focused vision of what is required to achieve academic, personal and social success. As a unique option in a new location adjacent to our FUHSD offices, Oasis projects a calm, supportive ambiance, a high graduation rate, and an energetic, curious, industrious, and well-rounded student body; student life is further enriched by outside speakers, annual field-trips, and additional student services provided by the District career counselor, impact counselor, drug & alcohol coordinator, and the District psychologist.

Oasis students come from Fallbrook, Bonsall, Rainbow, De Luz, and Camp Pendleton as well as from neighboring school districts via interdistrict transfer. Oasis provides a college preparatory and a regular education curriculum, requiring 230 total credits for graduation, which has allowed our graduates to enter college via the UC/CSU and California Community College Systems or via private colleges. In 2009, Oasis High School was evaluated as a candidate for accreditation by the Accrediting Commission for Schools of the Western Association of Schools and Colleges (WASC). In June 2009, Oasis High School became a fully accredited high school, earning a three year accreditation. In addition, beginning in the 2009-2010 School Year, Oasis students can concurrently attend Oasis and participate in CIF interscholastic athletics on Fallbrook High School athletic teams.

In 2008-09, the total operating cost for the Fallbrook Union High School District was \$27,216,841.78. This amount was derived from funds received from general education, special education and for federal, state, and local special projects. Funds were also received from the California State Lottery. The funds were spent for classroom- related activities, such as teachers, instructional aides, books, supplies, and equipment. The balance of the expenditures covered district support services, school administration, district administration, transportation, maintenance, and operations. Special categorical revenue was received for the following programs: 10th Grade Counseling; EIA/LEP, Title V, School Library, School Safety and Violence Prevention, Arts & Music and Title III.

Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including the California Standards Tests (CSTs); the California Modified Assessment (CMA), and the California Alternate Performance Assessment (CAPA). The CSTs show how well students are doing in relation to the state content standards. The CSTs include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and ten through eleven. The CAPA includes ELA, mathematics, and science in grades two through eleven, and for science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations. The CMA includes ELA and mathematics for grades three through eight and science in grade five and is an alternate assessment that is based on modified achievement standards. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations. Student scores are reported as performance levels. California High School Exit Examination Results

The California High School Exit Examination (CAHSEE) is primarily used as a graduation requirement. XII. Instructional Planning and Scheduling

Professional Development

Staff development occurs prior to school starting in the fall, during staff meetings, and during Professional Learning Communities on Monday mornings. A wide variety of professional development opportunities are available to teachers, administrators and paraprofessionals. Teachers and other staff participate in ongoing training to enhance their skills, such as visits to similar school sites and the CCIS conference on independent study schools. Professional literature and research are studied and shared on an ongoing basis, and the district-sponsored BTSAs Program provides support and coaching to teachers new to the profession. During 2008 and 2009, teachers were trained in a variety of areas including OARS, web site development, video conferencing, and Aeries Parent Portal.

XIII. National Assessment of Educational Progress

National Assessment of Educational Progress

The National Assessment of Educational Progress (NAEP) is a nationally representative assessment of what America's students know and can do in various subject areas. Assessments are conducted periodically in mathematics, reading, science, writing, the arts, civics, economics, geography, and U.S. history. Student scores for reading and mathematics are reported as performance levels (i.e., basic, proficient, and advanced) and the participation of students with disabilities and English language learners is reported based on three levels (identified, excluded, and assessed). Detailed information regarding the NAEP results for each grade, performance level, and participation rate can be found on the [National Assessment of Educational Progress](#) Web page (Outside Source).

Note: Only a sample group of California's schools and districts participate in the NAEP testing cycle. Therefore, students in any particular school or district may not be included in these results. The NAEP reflects state test results and is not reflective of either the LEA or the individual school. Comparisons of student performance on the NAEP and student performance on the Standardized Testing and Reporting (STAR) Program assessments cannot be made without an understanding of the key differences between the two assessment programs. For example, the NAEP only assesses grades four, eight and twelve and for long-term trends assesses grades nine, thirteen, and seventeen. Additionally, the NAEP only provides state test results for grades four and eight. The California Standards Tests (CSTs) are based on a different set of standards than the NAEP assessments. For example, the NAEP is not aligned with California academic content and achievement standards and, therefore, does not necessarily reflect the curriculum and instruction to which students are exposed in the classroom. The NAEP assesses reading and writing separately, while the CSTs assess English-language arts (ELA), encompassing reading as well as writing conventions, spelling, and grammar. Scores on the CSTs and other assessments are not directly comparable to those on NAEP. The averages and percentages presented are estimates based on samples of students rather than on entire populations. Finally, the questions students respond to are only a sample of the knowledge and skills covered by the NAEP frameworks.
