Common Core State Standards (C4))

Dr. Iñiguez presented a PowerPoint slide focusing on LCAP Goal 3: All students will demonstrate proficiency of state content, as an example of measureable difference. Students are being asked to have the ability to integrate knowledge and ideas when reading a text. He explained how we are working with teachers on how to teach these standards so students are learning and demonstrating mastery.

Revised Board Policy and Administrative Regulation 6142.1 Sexual Health and HIV/ AIDS Prevention (C5)

Dr. Iñiguez explained that we are in compliance as a District and that the minor revisions are to clarify that we are not teaching a comprehensive sexual education course. Health is currently integrated into the PE classes and would continue.

Board members would like to see if the Health course could come back in the future at FHS.

Dr. Pedroza explained there are a couple of issues to be reviewed such as master schedule and it being a semester course. We will revisit and come back with specific options how the course could be brought back. Recommends that we move forward with approval of the revisions of the BP and AR to line us up and continue to have us in compliance.
