## Mr. Brian Kantner


Ag Teacher - FUHS





# Carl Maier


Student Board Representative Alternate for SDCOE

Forty-eight students from across the county submitted applications to represent one of the five districts within the county. Carl has been appointed as the alternate for District 5.



# Citizens Oversight Committee (COC)



In accordance with Bond Measure "AA", an Independent Citizens' Oversight Committee (COC) was appointed to assure Bond funds are being spent as outlined in the Measure "AA" Bond Measure ballot language. The COC was appointed within 60 days of the date that the Board entered the election results in its minutes pursuant to Education Code 15274.

The COC was appointed on March 13, 2017.

COC members are appointed for two year terms and may renew their term up to three times. Currently, the term of service for each of our COC members expired in the Fall of 2020. None of the COC members expressed an interest in renewing their appointment. There are five vacancies on the COC.



# Citizens Oversight Committee (COC) membership

The COC is comprised of specific members of our community including:

- a Business Representative
- a Senior Citizen Group Representative
- a Taxpayer Organization Member
- a Parent or Guardian of a Student Enrolled in the District (FHS)
- a Parent or Guardian of a Student Enrolled in the District and Active in a Parent-Teacher Organization
- an At-Large Community Member.

# **COC Responsibilities**

Two year commitment.

Attendance at COC meetings which are held at least 2 times a year to review the progress of Bond construction and spending. Each meeting consists of:

- descriptions of projects
- schedules and financial status of Bond monies.

FUHSD staff provide information and answer to questions from committee members. The meetings consist of members receiving reports including information on each school site's proposed projects, their status and the cost of construction to date. The COC determines if the District is in compliance with Measure "AA" Bond language, and Proposition 39. The COC, through the COC chair, prepares and presents an annual report to the Board.
