Our Theory of Action

If we create a safe, equitable, effective, and programmatically diverse instructional model that is both, geographically fluid to account for the numerous uncertainties in the 2020-2021 school year, and rigorous and engaging then we will allow students to socially and academically collaborate in a safe manner where all students have a sense of ownership over their learning.

Current CDPH Guidance

- Establish a written, worksite-specific COVID-19 prevention plan at every facility
- Promote healthy hygiene practices
- Require face coverings
- Ensure teacher and staff safety
- Intensify cleaning, disinfection, and ventilation
- Implement distancing inside and outside the classroom
- Limit sharing
- Train all staff and educate families
- Check for signs and symptoms
- Plan for when a staff member, child or visitor becomes sick
- Maintain healthy operations
- Considerations for reopening and partial or total closures



We will not transition for the sake of transitioning. We will transition when the experience we can create is better than our current model and when we can implement all CDPH guidelines.

CDPH Guideline: Areas of Concern

- 1. Implementing distancing inside and outside of the classroom.
 - Maximize space between students on school buses.
 - Minimize contact at the beginning and end of the school day.
 - Minimize movement of students and teachers or staff.
 - Band and choir practices are not permitted.
 - Minimize congregate movement through hallways as much as practicable.
- 2. Routine testing for all staff (testing ½ of staff every other month).

Instructional Support

Aside from the supports embedded in the APEX Digital Curriculum, FUHSD:

- is supporting students with Individual Education Plans (IEP) through para-educators that are a part of the online learning community. Paraeducators work with students in small groups and are receiving ongoing professional development addressing virtual classrooms and instruction.
- is supporting our English learners through our bilingual para-educators that are a part of the online learning community. Another source of support is APEX which provides translation and Online Learning Partners in classes without a paraeducator.
- is assisting students with poor or no internet connectivity are receiving technology support to ensure they are able to access learning.
- students are receiving lessons and guidance on cyber citizenship, navigating online learning, and learning strategies to best manage their time and their learning in Advisory.
- is hiring Online Learning Partners to assist students in accessing
- is currently working on a plan for small, cohorts of students to report to campus for extra support (outside of instructional time).



Extra-Curricular Opportunities

- Access to facilities and practices for competitive sports that begin competition in December.
- College and Career Center activities and information.
- Associated Student Body (ASB) activities.

Breakfast and Lunch

Children 18 years of age and younger continue to receive meal assistance. Meal pick up is on Tuesday and Thursday from 7:00 a.m. to 8:30 a.m. and 3:00 p.m. to 6:00 p.m. Families receive meals for each child on Tuesday for Tuesday and Wednesday and on Thursday for Thursday through Monday.
